TUITION FEE INSTALMENT PLAN FORM

Important Information

This form is to be used by UOW College students that are experiencing financial difficulty in paying full tuition fees by census date. This instalment plan is not available for students with;

- A history of unreliable payment of outstanding fees,
- International students that are enrolling in their first session of English Language program or Academic program, and/or
- Outstanding fees incurred on past enrolments.

Tuition Fee Instalment Plan Procedure

- Student is required to present their UOW College student ID card for verification.
- Fees Officer will check the student's eligibility i.e. enrolment, current address and payment history.
- Student must not have any outstanding tuition fees and ancillary charges from past sessions. Any outstanding fees must be paid prior to signing a Tuition Fee Instalment Plan contract.
- Student and Fees Officer will complete the Tuition Fee Instalment Plan contract together in which student must read and accept the terms and conditions prior to signing the contract.
- Tuition Fee Instalment Plan contract must be signed in front of Fees Officer.

Instalment Payment Structure

- Tuition fee instalment plan consists of three instalment payments.
- All instalment payments are to be paid by credit card only.
- The due dates for each instalment payment will be calculated based on the number of weeks per Academic Session or as per intake of English Language Program.
- The first instalment payment is due on the first day of class commencement with a minimum payment of 33.34% per Academic session fee or per intake of English Language program fee. A minimum of 33.33% payment for the remaining two instalment payments.
